Personal Data

Personal data includes all data with which you are direct or indirect identifiable such as your name, address, email and phone data.

Use of Personal Data

The use of personal data covers: collecting, saving, arranging, adjusting, changing, reclaiming, consulting, using, providing by transmission, spreading and any other way of launching your personal data as well as shielding, collecting, deleting or destroying this.

Above information applies to your first and last name, your address, your phone number and email address.

Aims

We need to use your personal data for following aims:

- to contact you about a purchase you made
- to make offers or agreements
- to deliver our product or service to you
- to send you our creative newsletters (via Laposta) only if you have permitted us to do so
- due to legal obligations

Your personal data will only be used for above mentioned aims. We will never sell your personal data to third parties, unless this is required because of legal obligations or legitimate interest like reasonable course of business.

Your rights

You are entitled to review, rectification, screening or deleting your personal data at all times.

Send your request by email to hello@yukkuristudio.com. To verify that you are sending the request, we ask you to include a copy of your ID. To protect your privacy we ask you to remove or blur your social security number and picture. We will react at your request as soon as possible but latest within four weeks. Also we want to call attention to the possibility to file a complaint at the Authority private data.



Storage Personal Data

All your personal data will be removed after 5 years. We will store this data no longer than strictly required to work our aims or dictated by law.

Data Security

Personal data is and must stay personal. We think it is of great importance that your personal data is not accessible for unauthorized persons and protected against illegal use. Therefore we apply all possible measures to work safely with your data. We use secured software, passwords for electronic systems, secured internet access and back-ups.

Mapping website visitors

To achieve the best possible working website Yukkuri Studio uses cookies, which are small text files. This website places cookies on your device. These cookies help us to analyse the visits paid to our site with Google Analytics. They also help us to optimize the performance of the site.

When you visit the site for the first time you will be informed about cookies and asked for permission to place them. You can invalidate the use of cookies by adjusting your web browser. Also earlier stored information can be deleted via your browser.
